#### Why a Round Table?

Setting up a language business is extremely easy in almost all segments of the language industry and in almost all countries in Europe. While that may make the language industry a very open and hospitable industry, the downside is that anyone can join in and try to sell anything. For most language professions there is no need for a degree, certification, quality label, experience, membership of a professional association or references. The result is an industry where many customers run into bad experiences and consequently perceive the value of language work rather low.

Research shows that the quality segment of the market suffers most from low status. Low status is not only harmful for an industry's profitability, it doesn't help attract young professionals or high potential to the industry. The effect, if no action is taken, can be a very vicious circle.

### **Who Should Attend?**

This Round Table invites anyone who is concerned with the status of language professions in Europe and is willing to share thoughts and ideas that may enhance the status of these professions.

### **Round Table?**

This Round Table will be moderated by Dries Debackere, an international business consultant with over 20 years of experience in facilitating dialogue and helping translate thoughts and ideas into recommendations and concrete suggestions for action.

Following the Round Table, a report, including its outcome, conclusions and recommendations for action to enhance the status of the language professions in Europe will be made public by The Language Industry. The report will also include a list of the participants.
